DATE AND PLACE OF DEATH 16 Jun 44, Vienna, Austria
CAUSE OF DEATH Bomb Bay was on fire when I bailed out. I tapped McGee on the shoulder and told him to follow me out. I did not see him leave and don't think he got out. All the rest of the crew have been accounted for, but none of us ever saw or heard about McGee again.
