

SUBJECT: Orders.

7 September 1944

TO : All Concerned.

1. The following named Off and EM, released prisoners of war from Rumania, are held fr asgmt to orgns as indicated, WP fr pres sta on or about 8 September 1944 to Repl Depot No. 7, rptg upon arrival to CO thereat for trans-shipment to the United States by first available surface transportation. Travel via mil acft, govt mtr T and/or rail is auth fr pres sta to Repl Depot No. 7. Upon arrival in US or upon completion of any temp dy as may be directed CG, Port of Debarkation, is authorized to grant personnel a leave of absence or furlough of twenty-one (21) days before rptg to a perm sta. CG, Port of Debarkation, is auth to place personnel on temp dy with the FOI Mil Intelligence Service, Washington, D. C., for a period not to exceed three (3) days. CG, Port of Debarkation, will reassign personnel to an AAF Redistribtuion Station near desired place of leave of absence or furlough and rpt arrival and asgmt to the CG, AAF, Washington, D.C. PCS. TCNT. TDN 91-66 P 431-02 A 0425-24.

2. Personnel will immediately notify correspondents and publishers to discontinue mailing letters and publications to them until further advised as to new address. WD AGO Form No. 971-1, 9 October 1943 (V-Mail Notice to Correspondents and Publishers) may be used for this purpose.
